During the calendar year of 2019, JBCP received a total of 40 manuscript, out of which 28 articles (70%) were rejected in the preliminary screening due to plagiarism or being out of the format and peer review process. During 2019 around 11 articles were subjected for publication after they are accepted in the peer review process. In the 2 issues of Volume 10 published during the year 2019, a total of 11 articles were published (at an average of 5

articles per issue) of which, articles were published from authors all around the world. Globally articles have been accessed by the research scientists and also cited.
